

# Cookie management policy

UPPA makes every effort to protect the personal information of users of its website and the associated websites of its components, in accordance with European and French regulations.

This Cookie Management Policy is intended to inform users of the UPPA website and the websites associated with its components of the conditions and purposes of use of cookies that may be present on [www.univ-pau.fr](http://www.univ-pau.fr).

In order to adapt the site to the needs of its visitors, we measure the number of visits, the number of pages viewed and the activity of visitors on the site and the frequency with which they return.

## What is a cookie?

A cookie is a text file placed on your computer/tablet/mobile phone when you visit a website. It enables the site to remember your actions and preferences (user name, language, font size and other display settings) for a given period of time, so that you do not have to re-enter this information each time you visit the site or navigate from one page to another. It is also used to collect information about your browsing habits and to offer services tailored to your device (computer, tablet, mobile).

These cookies are managed by the browser software (Mozilla Firefox, Google Chrome, Safari, Internet Explorer, to name but a few). Under no circumstances are they likely to damage your device.

## What do we do with cookies?

In order to tailor the site to visitors' needs, we measure the number of visits, the number of pages viewed, visitor activity on the site and the frequency with which visitors return.

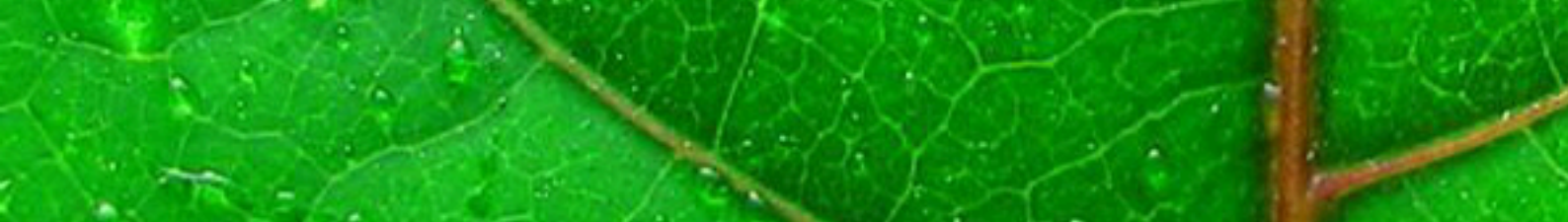
The statistics tool used by the Université de Pau et des Pays de l'Adour generates a cookie with a unique identifier, which is kept for a limited period of 6 months. The data collected is not passed on to third parties or used for any other purpose. You can object to this cookie or exercise your right of access to your statistical data by visiting the Cookies & Statistics page.

## What cookies do we use, for how long and how do you manage your consent?

These are audience measurement cookies used to understand how visitors interact with the website. The table below lists the cookies that may be deposited and used on the Université de Pau et des Pays de l'Adour websites. They are all provided by the Matomo tool:

Name of cookies	Purpose	Shelf life
_pk_id	Used to anonymously distinguish each Internet user.	3 months



_pk_ref	Used to identify a visit by the link from which the user arrived on the site.	6 months
_pk_ses	Used to temporarily store visit data.	30 minutes
mtm_consent, mtm_consent_removed, matomo_ignore	Used to manage consents.	30 years old

Users always have the option of modifying or withdrawing their consent via the cookie consent manager below.
